## Rules & Regulations for Online Raffles at Southeastern Adams Volunteer Emergency Services (SAVES)

- 1. Participants must be 18 years of age or older to purchase and win.
- 2. Purchasers are required to utilize a valid email address to which they have access during the purchase checkout process. The ticket sale platform will deliver electronic tickets to the purchaser at this address and tickets will not be available through other means.
- 3. Ticket numbers will automatically be assigned in sequential order by the ticket sale platform. No requests for specific ticket numbers will be honored. Any ticket number, as printed in the upper right of the electronic ticket, that is less than 4 digits will be assumed to have leading zeroes (e.g., ticket "N°1" is 0001, ticket "N°29" is 0029, etc.)
- 4. Tickets purchases will not be refunded except at the sole discretion of SAVES.
- 5. SAVES members are eligible to participate in this raffle.
- 6. The raffle drawing will be held a minimum of seven (7) days after the sale of the last ticket and will be conducted in the SAVES hall at 5865 Hanover Rd., Hanover, PA 17331. The drawing will be broadcast live via Facebook Live at <a href="https://www.facebook.com/SAVESco29">https://www.facebook.com/SAVESco29</a>. All ticket purchasers will be notified of the exact date and time of the drawing via the email address provided during the ticket purchase checkout process, on the SAVES website <a href="https://www.company29.org/content/raffle/">https://www.company29.org/content/raffle/</a>, and on the SAVES Facebook page. Purchasers should whitelist the <a href="mailto:company29.org">company29.org</a> domain in order to ensure receipt of the notification email.
- 7. The drawing will be made utilizing the "Random Integer Set Generator" on the Random.org website (<u>https://www.random.org/integer-sets/</u>). SAVES will initiate one (1) set of three (3) numbers to be generated, separated by commas and with no sorting. In the generated set, from left to right, the first number will be the Grand Prize winner, the second will be the Second Prize winner, and the third will be the Third Prize winner.
- 8. Winners will be notified via the email address and/or telephone number provided, and a list of winning ticket numbers and winner names will be posted to the SAVES website and Facebook page.
- 9. All purchasers will be required to submit their legal name, current address, and valid phone number for each ticket purchased, as required by Pennsylvania gaming regulations. If a participant completes a transaction to purchase for another individual, the other individual's information must be submitted for all tickets being purchased on the other person's behalf. SAVES will not be held responsible for a purchaser's failure to enter correct information at the time of ticket purchase to allow for proper verification of a winner's identity.
- 10. All winners will be verified via governmental photo identification (e.g., driver's license, passport, etc.) and must match the information entered at the time of purchase for each winning ticket prior to the prize being awarded.
- 11. SAVES will not be held responsible for the inability to verify a winner's identity and subsequent awarding of the prize due to the failure 1) of the purchaser to enter accurate and complete information during the purchase process; or, 2) of the winner to possess valid governmental photo identification that matches the information entered.
- 12. The Grand Prize vehicle may be viewed in person at Gene Latta Ford, 1565 Carlisle Pike, Hanover, PA 17331 during normal business hours while raffle tickets are still available. Test drives of the prize vehicle will not be allowed prior to award or by anyone other than the winner.
- 13. The Grand Prize vehicle must be claimed in person within thirty (30) days of notification to the winner at Gene Latta Ford, 1565 Carlisle Pike, Hanover, PA 17331. Winners must preschedule an appointment to claim the vehicle with Gene Latta Ford personnel and must notify SAVES at least three (3) days prior to claiming the vehicle to allow SAVES to publicize the event.
- 14. Ownership of the Grand Prize vehicle may only be transferred to a person with a valid driver's license and the winner must have proof of current insurance coverage on the vehicle before taking possession.
- 15. The purchase price of the vehicle as described on the raffle announcement, associated Pennsylvania sales taxes, and the cost of standard Pennsylvania tags and title will be the responsibility of SAVES.
- 16. Any vehicle upgrades; service plans; vehicle insurance; sales tax, tags, and/or title for a state other than Pennsylvania; or any other additional charges not specifically identified as the responsibility of SAVES will be the responsibility of the grand prize winner.
- 17. The Grand Prize vehicle is raffled as-is and may not be exchanged for any other vehicle or monetary consideration prior to transfer of ownership.

- 18. Cash prizes awarded as Second and Third Prize will be issued via business check from SAVES and must be claimed in person at SAVES, 5865 Hanover Rd., Hanover, PA 17331. Winners must make prior arrangements with SAVES to claim their prize within thirty (30) days of notification.
- 19. All income taxes due to the United States; Pennsylvania; or any other state, territory, or locality for any prize awarded will be the responsibility of the respective prize winner. All winners will be issued an IRS Form 1099.
- 20. A single ticket will be eligible to win only one prize. The electronic drawing method identified above will not generate duplicate numbers within the same set.
- 21. SAVES is a registered 501(c)(3) organization. Small Games of Chance license number 1101 (Adams County, PA). Special Raffle permit number SPR24-0832 (Adams County, PA).
- 22. All raffle proceeds go to SAVES operating expenses.
- 23. SAVES reserves the right to cancel the raffle at any time prior to the drawing and for any reason by refunding all ticket purchases then completed.
- 24. SAVES reserves the right to make changes to any or all prizes that results in a value for that prize equal to or greater than the original prize value. Notification of any such changes will be advertised on the raffle sale platform, SAVES webpage, SAVES Facebook page, and via email to any purchases already completed. Such changes will not be grounds for refunds of purchased tickets, unless specifically authorized by SAVES at the time of notification.
